NARRATIVE	
1	Licensing Program Analysts (LPAs) Williams and Hiratsuka arrived at the facility unannounced on
2	05/26/2021 to conduct a Required-1 Year Inspection utilizing the infection control domain. LPAs met with
3	Administrator, Kristie Laine, and explained the purpose of the visit. Prior to initiating the annual
4	inspection, LPAs completed required COVID-19 testing protocols, and a daily self-screening
5	questionnaire for symptoms of COVID-19 infection to affirm no COVID-19 related symptoms and
6	contacted licensee and completed a facility risk assessment. LPAs ensured they applied hand sanitizer
7	before entering the facility and the following Personal Protective Equipment (PPE) was worn: N-95
8	Respirator and surgical mask, respectively. Additionally, LPAs were screened by facility staff upon
9	entering the facility.

11	LPAs and staff toured facility together to ensure health and safety of residents in care. Areas toured
12	include but are not limited to: common areas, six (6) resident bedrooms, numerous bathrooms, kitchen,
13	dining room and courtyard. In the areas toured no immediate health, safety, or personal rights violations
14	were observed. LPAs and administrator completed the infection control domain and facility was found to
15	be in substantial compliance at this time.

17	No deficiencies are being cited as a result of today's inspection.
