<b>NARRATIVE</b>			
1	Licensing Program Analyst (LPA) Tiffany Holmes conducted a Pre-Licensing Virtual Visit, LPA was		
2	greeted at the front door by Zayden Chen, Owner. LPA was granted entry after identifying herself and		
3	disclosing the purpose of their visit. The LPA and owner toured the physical plant, and LPA observed the		
4	following: resident accommodations, including furnishings, linens, and personal hygiene items; resident		
5	bathrooms were equipped with non-skid mats, and water temperature measured at 108.8 degrees		
6	Fahrenheit in bathroom designated for use by residents; resident and staff records will be located in a		
7	locked cabinet in the administrators office; food service, including dishes, utensils, refrigerators,		
8	freezers, and adequate food storage and preparation space are present; cleaning and potentially toxic		
9	substances are stored in a locked cabinet in the laundry room; the storage of medications are in a med		
10	cart in the administrators office also; first aid kit is stored in a locked closet; sufficient space in which to		
11	conduct activities is present; a fire extinguisher is present and mounted in the facility kitchen; smoke and		
12	carbon monoxide detectors are present, and determined to be operable; required facility postings are		
13	present and visible in a common area of the facility. According to the administrator, there are and will be		
14	no guns, weapons, or ammunition stored on the facility property. No swimming pool on site and there is		
15	an open body of water that was observed on the facility property with a Koi pond that is gated and far		
16	away from the facility building. The administrator's certification for Ma Teresa Derafera, Administrator		
17	expires on 11/13/2022.		
18	Component III was conducted and completed following the pre-licensing physical inspection. Items		
19	reviewed during the visit are in compliance with Title 22, Division 6, Chapter 8, of California Code of		
20	Regulations. The licensee was advised that the application is pending management final review and		
21	approval. A copy of this report and Applicant Rights (LIC 9058) were provided to Zayden Chen, Owner.
