	Findings Include: According to the Single Contact License and Background Check (SING), Staff K, Registered Nurse (RN) had a hit on Dependent Adult Abuse on 4/6/21. The document indicates the facility was to submit a form (470-0643) to DHS for evaluation. A DHS Record Check Evaluation dated 4/19/21 indicates Staff K had been approved to work. An email sent to the Administrator on 1/7/22 at 9:33 a.m., from the State Compliance Officer for the Abuse Coordinating Unit (ACU), states Staff K had been recently added to the DHS Central Registry regarding an allegation of Dependent Adult Abuse at another facility in February and March 2021. The email instructs the Administrator to follow policy and applicable Iowa law regarding Staff K's continued employment. The facility conducted a background check on 1/11/22 and according to the Single Contact License and Background Check (SING), Staff K had a hit on Dependent Adult Abuse. The document indicates the facility was to submit a form (470-0643) to DHS for evaluation.

	In an interview on 4/13/22 at 9:00 a.m., the Administrator stated Staff K was hired on 4/28/21. Staff K had a Criminal and Dependent Adult Abuse (DAA) history which was disclosed prior to hire and in the background check process on 4/6/21. The Department of Human Services (DHS) was provided the background information and on 4/19/21 approved Staff K to work. On 1/7/22 the Administrator received an email from the State Compliance Officer for the Abuse Coordinating Unit (ACU) informing her that Staff K had been recently placed on the DHS Central Registry. The Administrator was instructed to follow the background check policy. The Administrator stated they re-ran the background check (1/11/22) which showed a hit under Criminal and Dependent Adult Abuse (DAA). The Administrator stated that since they had already received DHS approval for Staff K to work, they did not re-send another DHS evaluation request as thought the facility did not need to. The Administrator stated they suspended Staff K on 4/13/22 pending the outcome of the DHS evaluation sent in today (4/13/22). On 4/20/22, the Department of Human Services provided the facility a Denial Notice indicating Staff K was not granted approval to work for the facility based on their evaluation.
