The census at the time of the survey was seven. The sample size was six. The facility received a grade of A. There was one complaint investigated. Unsubstantiated: 1. Complaint #NV00012745 could not be substantiated. No regulatory deficiencies could be identified. The investigation of Complaints included: Observation of grooming and physical appearance for residents, resident rooms, smells within the facility, residents eating their breakfast, and a tour of the facility. Interviews were conducted with residents, a Caregiver, and the Owner.
