1. Requirements

2600.

227.h. If a resident or designated person is unable or chooses not to sign the support plan, a notation of inability or refusal to sign shall be documented.

Description of Violation

Resident [REDACTED] participated in the development of their initial support plan on [REDACTED]. The resident did not sign the support plan. The home did not make a notation regarding the residents' inability to sign.

Plan of Correction**Accept [REDACTED] - 06/17/2025)**

The Health and Wellness Coordinator fixed Resident [REDACTED]'s support plan immediately, on 4/25/25, by having that resident sign the support plan.

Moving forward, if a resident chooses not to sign the support plan or is unable to due to physical or cognitive limitations, the reason will be clearly documented. The resident's preferences will be prioritized and it will be ensured their needs are met, even if they cannot sign their care plan. The care plan will also outline how the family or legal representative was involved in the care planning process, especially if the resident is unable to participate directly. The Health and Wellness Coordinator, who is responsible for all support plans, put this into place as practice on 4/25/25. The Health and Wellness Director does monthly audits of support plans, the first week of every month, to ascertain that all support plans completed the previous month meet state requirements.
