## **Facility Information**

Village Community Care Home -Unit B is located at 1250 Salem Church Rd. Anderson, SC 29625-1310 in Anderson County. The facility is licensed for 11 beds. During the visit, the facility had 11 Residents. The current DHEC license was posted with an expiration date of January 31, 2025. The current Administrator's license was posted, and the administrator is listed as Phyllis Williams. The current written emergency plan was available for review onsite. In the event of an emergency, the facility will evacuate to Oconee Disabilities and Special Needs Board located at 116 South Cove Rd. Seneca SC, 29672. An exit interview was conducted with the Administrator.

## **Overview of Visit**

During Team's visit, residents were interviewed, medications, and the Medication Administration Record (MAR) was reviewed. Team did not observe lunch. The posted and served meal were the same. The meal consisted of chicken nuggets, potato wedges, and a drink.

## Report Summary

The facility's water temperature was 119.0 degrees. Resident B's current physical exam was not available for review. Also, Resident B's current care plan was not available for review.

- Staff appeared to have good rapport with the residents.
- The facility had sitting areas for residents that included a TV, and comfortable looking sitting chairs for residents.
- The facility had a covered porch with seating for the residents.
