Comments:

This inspection was conducted by licensing staff using an alternate remote protocol necessary due to a state of emergency health pandemic declared by the Governor of Virginia.

A renewal inspection was initiated on 4/21/2021 and concluded on 4/22/2021. The administrator was contacted by telephone to initiate the inspection. The administrator reported that the current census was 71. The inspector emailed the administrator a list of items required to complete the inspection. The inspector reviewed four resident records, four staff records, annual fire and health inspections, dietary and healthcare oversight reports, fire drill reports, staff work schedule submitted by the facility to ensure documentation was complete. The Criminal Background Checks for all new staff hired since the last inspection completed on 5/29/2020 were reviewed. The administrator was interviewed upon initiation of the inspection and at the exit interview.

The information gathered during the inspection determined no violations with applicable standards or law. No violations were issued. The exit interview was conducted via telephone on 4/22/2021.
