Management will continue under current company. Policies and procedures were reviewed. The most recent health and fire inspections were provided with a leniency noted due to the state of emergency; LI confirmed that both inspections are currently scheduled dependent on county availability.

An exit interview was conducted with the Administrator on 3/15/2021. No violations were cited.
